In 2016, 98 delegates from 20 countries attended the 16th International Water Mist Conference in Vienna, Austria. The 20 speakers had travelled from 10 countries to give their presentation.









Once again, a panel discussion was part of the conference. Jonathan Carpenter (FM Approvals), Christian Kopp (VdS), Markku Vuorisalo (Marioff) and Rüdiger Kopp (Fogtec) discussed "The Quality of Water Mist Systems". Luciano Nigro (Hughes Associates) acted as moderator.



IWMC 2016 - the Topics

The 16th International Water Mist Conference was an event packed with highlights. Joachim Böke (MinimaxViking), chairman of CEN/TC 191/WG 10, updated the audience on the European Standardization Work.

- Local Water Mist Protection Systems: Demonstrating Competent Design

IWMC 2017 - Date, Venue, Timetable

Another issue which was discussed during the IWMA member meeting was the date and venue for next year's conference. And here are the details: The 17^{th} International Water Mist Conference will take place in Rome, Italy at the Barceló Aran Mantegna Hotel on 25^{th} and 26^{th} October. Please note that the initial date -20^{th} and 21^{st} September - is no longer valid!



The timetable looks like this:

- The Call for Papers will be released on 15th January 2017.
- The Abstract Deadline is 15th May 2017.
- Speakers will be notified by 15th June 2017.
- The conference webpage will be activated on 15th May 2017.
- The early bird period during which delegates can profit from special rates will end on 15th
 July 2017.
- The conference programme will be published on 1st July 2017.
- A first draft of the agenda for the 2017 IWMA Member Meeting will be sent out on 19th July two months prior to the meeting. The IWMA members will then have six weeks to hand in further items that they feel should be discussed.
- The final agenda will be distributed on 5th September 2017 two weeks prior to the meeting.
- The annual IWMA Member Meeting 2017 will take place in Rome, Italy on 19th September 2017. The name of the meeting room in the Barceló Aran Mantegna Hotel will be announced in due course.

Travel Report

In late September, Bettina attended the <u>"Sustainable Fire Engineering Conference"</u> in Dublin, Ireland. The day prior to the conference was dedicated to the authorized revision of ISO 21542



(Building Construction – Accessibility and Usability of the Built Environment) which was last published in December 2011. This standard's issue is the evacuation of people with disabilities, impairments, limitations.

The organizer C.J. Walsh argues that not enough is done for that group which is not a small group. After all there are: wheelchair users, the elderly, young children, pregnant women, people with physical as well as mental health issues. In fact, 10 per cent of people have disabilities and 15 % are impaired by other activity limitations. Some concrete items were:

- refuge areas,
- areas of rescue assistance,
- evacuation equation: add lifts and elevators!
- Safer architectural forms
- etc.





Bettina in Dublin: Fire Safety for All / Sustainable Fire Engineering

During the conference on sustainable fire engineering the main question was how to design, construct, operate and manage buildings in a sustainable way. Here, Bettina had the opportunity to introduce water mist as one of the - if not THE - most sustainable way to protect a building.

NFPA 750

In October, Bettina together with Rüdiger Kopp (Fogtec) attended the "NFPA 750 First Draft Meeting" in Memphis, Tennessee, USA. First IWMA representative and principal when it comes to NFPA 750 is Max Lakkonen (IFAB) who was unable to attend. Thus, Rüdiger stood in.

What was discussed during the two-day-meeting has to remain behind closed doors. However, there are some dates and facts available for publication:

- The current edition of NFPA 750 is the 2015 edition.
- It can be purchased as a pdf-version or a book for \$ 50.50. There are no charges for viewing the online version.



- The next edition is due to be published in 2019.
- The First Draft Report Posting Date is: 1st March 2017.
