## **IWMA supports OFSEC 2017**

The third edition of OFSEC – Oman's only exhibition on fire, safety and security will take place in Muscat (Sultanate of Oman) from 9th to 11th October 2017. Venue is the Oman Convention & Exhibition Centre.

Again, he will have the chance to talk about "smaller droplets, thinner pipes". Alex's topic on both days will be: Current status of water mist. He says: "In a way this is proof of that water mist is seen more and more as an accepted technology in the fire protection community."
